



Police Report – March 2016

In March we received 318 calls from members of the public relating to incidents across the three parishes.

Crime Alert

There is a graffiti tag 'Trouble' that has appeared in Glenfield. We request that if you hear of or know any information in relation to who is responsible for this that you get in touch with the local beat team.

We have received numerous calls from vigilant residents during March from locating stolen cars to reporting crimes in progress. One of which in Leicester Forest East allowed us to track down the suspects and make arrests and seize their vehicle.

A call was made by a concerned neighbour in Kirby Muxloe following a building company cold calling. Enquiries have been made and trading standards have been passed information to look into whether any trading standards offences have been committed. Please ensure that you do background checks on all companies you have home improvements undertaken with. If you have any concerns with a company's practice or concerns for a neighbour having work done then please inform the Police and Trading Standards.

Anti-Social Behaviour

Youths acting in an antisocial manner in Glenfield escalated during March with various locations having issues. As a result there were dedicated patrols put in place supported by neighbouring beat teams. A dispersal zone was put in force for a short period in conjunction with these patrols and as a result several more individuals have received warning letters from the District Council as well as banning letters from the COOP and police visits to parents which has seen a reduction in the behaviour. Local residents have been surveyed around Station Park but the issue hadn't affected most of the local residents. With the behaviour now being improved the extra patrols have now ceased with the beat team continuing to concentrate on and monitor/deal with any issues.

The issue of motorbikes on Forest East Park in LFE reduced significantly although no persons have been identified in relation to this the Police, Parish and District Councils are working toward assessing what sort of



changes to the park can be made to reduce the chance of the issue reoccurring. Consultations of local residents also confirmed that they were not experiencing the problem as often as they had been.

Motorbikes have also been causing a nuisance on the Western Park Golf Club to some residents in Glenfield. The neighbouring beat team have contacted the City Council who will repair the make shift entrances that allow the motorbikes onto the fields. Given that the area is such a vast piece of land it is difficult to locate and catch anyone riding on the land. Patrols continue and some arrests have been made relating to offences on the property. We continue to tackle this problem when it is happening.

Community Engagement

A consultation was undertaken around Maytree Court in Kirby Muxloe with no significant issues being identified at this shopping location although dog fouling was highlighted to us. Signs have been placed in the area. It is an offence to fail to clear up after a pet and any information relating to such matters can be passed onto the District Council or local Police to forward onto them.
